 - c. The final audit report has yet to be received by the Synod office.
- 15. Bishop's Report:
 - a. Noted that Bishop Easton is taking a leave of absence.
 - b. Stewardship will solicit gifts for lay school funding
 - c. Noted staff changes since the last meeting
 - d. Gave a summary of his visit to the Central African Republic (CAR). The people were very gracious and accommodating. They were very appreciative of the bishops coming there to celebrate their anniversary in spite of the dangers. The enthusiasm of the people was amazing.
